- 4. Provide information about and referrals to social service agencies or community programs that may be of assistance to clients.
- 5. Maintain complete, accurate and up-to-date client files, including client intake information, budgets, action plans and any other documentation provided by clients during the course of counseling.
- 6. Timely data entry of required client information and counseling log notes in the appropriate database.
- 7. Maintain regular contact with clients as necessary per counseling guidelines.
- 8. Provide these counseling services at off-site satellite locations when requested by BFEC Manager and/or as mutually agreed.

Other Functions

- 1. Serve as back up to the BFEC Intake Coordinator as needed.
- 2. Participate in staff meetings and training. (Overnight travel may be required for some training)
- 3. Represent Tenfold and the BFEC at community meetings when requested.
- 4. Provide off-site financial workshops when requested. Up to 50% travel required within Lancaster and surrounding counties.
- 5. Maintain required certifications.
- 6. Perform other tasks assigned by the Director of Financial Empowerment.
