Waiver and Release from Liability and Media/Photography Release

This Waiver and Release from Liability and Media/Photography Release ("Release") is given by me for the benefit of Tenfold. I have been advised that such location is public, and I have no expectation of privacy with regard to my participation therein.

IN FURTHER CONSIDERATION OF PROVIDING ACCESS AND INTENDING TO BE LEGALLY BOUND HEREBY, ON BEHALF OF MYSELF, MY HEIRS, REPRESENTATIVES, EXECUTIVES, ADMINISTRATORS AND ANY OTHER PERSONS ACTING ON MY BEHALF OR ON BEHALF OF MY ESTATE:

1. I HEREBY RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE Tenfold, Lancaster Baseball Club LLC, Dakota Baseball LLC, Keystone Baseball LLC, and the directors, officers, employees and agents of any of the aforementioned entities (hereinafter collectively referred to as "Releasees") from all liability to me, for any loss or damage, and for any claim or demand therefor on account of injury to my person or property or resulting in my death as a result of participation in Tenfold's Camp Out for Homelessness to Housing whether due to the gross negligence or negligence, in whole or in part, of the Releasees, whether caused by the Releasees or otherwise.

2. I HEREBY AGREE TO INDEMNIFY, DEFEND, SAVE, AND HOLD HARMLESS the Releasees and each of them from any claim, loss, liability, damage, or cost including attorney fees they may incur as a result of my participation in Tenfold's Camp Out for Homelessness to Housing whether due to the gross negligence or negligence, in whole or in part, of the Releasees, whether caused by the Releasees or otherwise.

3. I HEREBY ASSUME FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE as a result of my participation in Tenfold's Camp Out for Homelessness to Housing whether due to the gross negligence or negligence, in whole or in part, of the Releasees, whether caused by the Releasees or otherwise.

4. I HEREBY GRANT RELEASEES PERMISSION TO USE MY LIKENESS in a photograph, video, or other digital media (collectively "photos") in any of its publications, including web-based publications, without payment or other consideration. I understand and agree that all photos will become the property of the Releasees and will not be returned.

I further expressly agree that the foregoing Release is intended to be as broad and inclusive as permitted by law and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

In signing this Release, I acknowledge and represent that I have read it, understood it and signed it voluntarily; no oral representations, statements or inducements, apart from the forgoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate, and complete consideration fully intending to be bound by the same. A parent/guardian signature is required for individuals under eighteen (18) years of age.
